DESCRIPTION

The Indiana Golf Foundation has established and maintains the Indiana Golf Hall of Fame for the purpose of recognizing, honoring and perpetuating the memory of those persons who have distinguished themselves by their contribution to the game of golf.

NOMINATION

The official application may be submitted by anyone and additional information such as letters of recommendation, articles, etc may be submitted along with the application. The application can be found on www.indianagolf.org or by contacting the Indiana Golf Office at 800-779-7271.

Deadline for nominations is September 30 for consideration of induction the following year. A nominee will remain on the ballot for a period of 5 years. If, after 5 years, the nominee has not been selected for induction, a new application must be submitted.

CATEGORIES FOR CONSIDERATION

- Playing Accomplishments
- Teaching and Coaching the game
- Administration and/or working within the game
- Golf Course Architecture
- Golf Course Superintendents
- Media

ADDITIONAL CONSIDERATIONS & REQUIREMENTS

- The nominee must have either been born in the state or have a significant connection to the state for a minimum period of 5 years
- The nominee should be at least 40 years of age. For nominees who are 40 years of age and are still actively playing competitively or working in the game, the normal age for consideration will be 50 years of age
- The nominee must have made a significant and lasting contribution to the game in one of the above-mentioned categories for consideration.
- The nominee's accomplishments should include statewide or national as opposed to local contributions and accomplishments
- The individual, over an extended period of time, must have exhibited interest and service above and beyond the expected at the highest level of excellence
