It is the purpose of this agreement to exempt, waive and relieve Releasees from liability for personal injury, property damage and wrongful death, including the negligence, in any, of Releasees. "Releasees" include the Indiana Golf Foundation, Inc. (the "Foundation"), the Gongaware Junior Golf Academy, the Indiana Section of the PGA of America, Inc., the IGA-PGA, Inc., L.O.I., Limited Partnership, and their affiliate associations, their officers, directors, agents and employees.

For and in consideration of the undersigned participant's registration with the Gongaware Junior Golf Academy and being allowed to participate in Foundation events, participant (and the parent(s) or legal guardian(s) of participant, if applicable) waive, release and relinquish any and all claims for liability and causes of action, including actions for personal injury, property damage or wrongful death occurring to participant caused by Releasee's negligence or arising out of participation in Foundation events, the sport of golf and/or activities incidental thereto, whenever or however they occur and for such period said activities may continue, and by this agreement any such claims, rights and causes of action that participant (and participant's parents(s) or legal guardian(s), if applicable), may have are hereby waived, released and relinquished, and participant (and parent(s)/guardian(s), if applicable) does(do) so on behalf of my/our and participant's heirs, executors, administrators and assignees.

Participant (and participant's parent(s)/guardian(s), if applicable) acknowledge, understand and assume all risks relating to golf and any related activities, and further understand that such activities involve risks to participant's person, including bodily injury, and damages which may arise therefrom and that I/we have full knowledge of said risks. These risks and dangers may be caused by the negligence of the participant or the negligence of others, including the negligence of the Releasees

identified above. I/WE further acknowledge that there may be risk and dangers not known to us and not reasonably foreseeable at this time. Participant (and participant's parent(s)/guardian(s), if applicable) acknowledge, understand and agree that all the risks and dangers described through this agreement, including those caused by the negligence of Releasees, are included within the waiver, release and relinquishment described in this agreement.

Participant (and participant's parent(s)/guardian(s), if applicable), acknowledge, understand and assume the risks, if any, arising from the conditions and use of the Foundation facilities, including, but not limited to, the golf course and related premises, and acknowledge and understand that included within the scope of this waiver and release is any cause of action (including any cause of action based on negligence) arising from the performance of failure to perform, maintenance, inspection, supervision or control of said areas and for the failure to warn of dangerous conditions existing at the Foundation facilities, golf course and related premises or for negligent supervision or instruction by Releasees.

Participant (and participant's parent(s)/guardian(s), if applicable) agree if any claim for participant's personal injury or wrongful death is commenced against Releasees, he/she shall defend, indemnify and save harmless Releasees from any and all claims or causes of action by whomever or wherever made or presented for participant's personal injuries, property damage or wrongful death.
